

INVITATION TO BID
FOR THE
Supply and delivery of one (1) unit Sport Utility Vehicle,
2.4L Diesel, M/T

1. The Philippine Council for Health Research and Development (PCHRD), through the General Appropriations Act (GAA 2016) intends to apply the sum of One million five hundred thousand pesos (P 1,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, and delivery of one (1) unit Sport Utility Vehicle, 2.4L Diesel, M/T. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PCHRD now invites bids for Supply, and delivery of one (1) unit Sport Utility Vehicle, 2.4L Diesel, M/T. Delivery of the Goods is required within thirty calendar days (30CD). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from Philippine Council for Health Research and Development (PCHRD) and inspect the Bidding Documents at the address given below during Weekdays, from 8:00 a.m. to 4:00 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders on February 01 to February 24, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One thousand five hundred pesos (P 1,500.00).

5. The PCHRD will hold a Pre-Bid Conference on February 12, 2016 (Friday), 1:30 p.m. at PCHRD office, which shall be open to all interested parties.
6. Bids must be delivered to the address below on or before February 24, 2016 (Wednesday), 1:00 p.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on February 24, 2016 (Wednesday), 1:30 p.m. at PCHRD Office Rm. 306 DOST Main Bldg., Gen. Santos Ave., Bicutan, Taguig City, Metro Manila. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The Philippine Council for Health Research and Development reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
