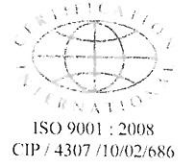



WHEREAS, the following are the quoted amount of the three (3) hotels:




WHEREAS, upon careful examination, validation and verification of all the submitted offers, it has been found to be responsive;

NOW, therefore, we, the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**;


- a) To declare **Dusit Thani Manila** as the hotel with the Lowest Calculated and Responsive Offer;




